\* McIver rooms are specially located close to the main lodge with bathrooms across the hall from the rooms and next to a large, spacious lodge. It is ideally suited for families with very young children or anyone with special needs/mobility issues as all other cabins are a bit of an uphill hike on semi rough terrain and do not contain bathrooms. ONLY FOUR ROOMS ARE AVAILABLE.

#### ARRIVAL/TIME/DEPARTURE TIME

Since the first weekend is shorter, the dates and times for arrival and departure are:

1st weekend (tide will be too low for barge crossing, we will walk in on the back road into camp, luggage will be transported for you, details will be included in your confirmation packet)

Friday, May 21: Hike / drive up emergency vehicle: 1:30 PM

Sunday, May 23: Hike: 11:00 AM; vehicle leaves at 10:30 AM

Friday, May 28: barge crossing in at Noon

Saturday, May 29: barge crossing in at 1:30 pm, maybe 1:00 pm

**Crossing Note:** Crossing times are subject to the tides as we are ferried across the Salmon River to the camp via a barge. Due to the restrictions on crossing via the barge to periods of high tide it is important to be prompt and allow time to unload kids, luggage, pails, shovels, etc. Life jackets are provided. This is a lovely boat crossing for those who have never been to the camp before. All human cargo are ferried across first and luggage is brought across on the cargo barge, so be prepared for a brief separation between yourself and your belongings. Luggage is best placed in large plastic bags/garbage sacks – this is due to possible exposure to rain/wet weather (this is the beach in Oregon after all). Label all belongings well.

We know that such activity may involve risks, and that the Participants may be injured as a result of the activity and/or as the result of the negligence of others participating in the activity.

We assume all risks and hazards incidental to the conduct of this activity and for the transportation to and from the activity. We authorize Oya No Kai to obtain medical treatment for the Participants in the event that the Parents or guardians cannot be reached.

With full knowledge of the above risks, we voluntarily relinquish any and all rights the Participants might otherwise have against Oya No Kai, its directors, officers and members from any and all claims or liability of any kind or nature whatsoever arising out of or connected with the Participants' participation in the activity. The consideration for this agreement is made on the Participants' behalf and is binding also upon the Participants' heirs, executors, administrators or anyone else who might try to claim on their behalf.

If anyone makes a claim or files a lawsuit due to the Participants' participation in the Camp Westwind sponsored activities, the Participants agree to hold Oya No Kai, its directors, officers and members harmless from such claim or lawsuit and agree to indemnify Oya No Kai, its directors, officers and members from any and all loss, cost or expense, including attorneys' fees and court costs incurred in defending such claim or lawsuit. This hold harmless agreement is also binding upon Participants' heirs, executors, administrators, or anyone else claiming or suing through the Participants or on their behalf.

To the extent any of the provisions set forth herein are invalid, they shall be severed and the rest of the provisions shall remain in force.
